The overall budget has decreased from last year, because the amount for restricted fund balance decreased and all capital projects have been fully funded. The amount to be raised by taxation will increase by approximately 40,000.

The variance in total fund balance utilized will increase to keep the tax rate stable. Interest investments decreased do to the lower interest rate this past year. The budgeted amount for election costs was increased to anticipate high election costs to run the election this up coming year.
